This 2005 Palmer Johnson 120 M/Y ESCAPE is a top-tier yacht from the shipyard's Sport Series. Measuring 36 meters, this yacht fuses elegant design with remarkable speed, achieving up to 26 knots. Renowned for its superior construction, M/Y ESCAPE is ideal for individuals desiring comfort as well as performance while boating. Kept in superb condition, it provides ample space for up to 8 guests in 4 cabins, featuring a full-beam master suite. The interior is carefully crafted to provide both seclusion and comfort, while the exterior boasts generous deck space for hosting guests and savoring the ocean breeze.

### LAYOUT:

The yacht's layout has been conceived to balance outdoor living with bright, open interiors. Three dedicated sunbathing zones are spread across the decks, complemented by an aft terrace that offers a private and atmospheric setting for dining on board.

Both the exterior lines and the interior styling have been crafted by Nuvolari & Lenard, resulting in a cohesive design that emphasizes elegance, natural light, and a strong connection between indoor and outdoor spaces.

A generous dining space is located on the aft deck, comfortably accommodating all guests, alongside an additional lounge area for 4 to 5 people. This area is sheltered by a well-proportioned Bimini top and provides direct access to the flybridge.

Inside, the main saloon features an additional dining table and serves as the central hub of the yacht, with convenient access to the galley and the crew's private quarters. The lounge itself is spacious and welcoming, offering seating for up to 9 or 10 guests and is enhanced by a dedicated bar complete with stools.

Forward of the main saloon, the wheelhouse is discreetly separated by a smoked glass partition. It includes a crew table and the yacht's primary navigation and control systems, with a direct doorway leading out to the forward deck.

M/Y ESCAPE is one of those yachts that immediately feels right the moment you step onboard. She offers excellent performance for her size, combined with a comfortable, sensible layout that works equally well for private use or entertaining. In our view, she represents a very compelling option in the 36-meter segment for an owner who values pedigree, speed and condition over hype.
