Originally delivered in 1999 and extensively refitted over the years, most recently in 2024, she presents in excellent condition with fully serviced machinery and upgraded exterior areas. Her steel hull and aluminium superstructure ensure robust performance and long-range cruising capability. Designed for comfort and elegance, she offers refined interiors, generous deck spaces and smooth cruising at 12 knots, making her an ideal yacht for extended voyages or commercial use under Maltese registration.

LAYOUT:

The layout of LADY IN BLUE is thoughtfully arranged to provide both privacy and spacious social areas across all decks. She accommodates up to 10 guests in 5 well-appointed cabins, each with en-suite facilities, complemented by an additional day head. The main deck features a large saloon with a formal dining area and a newly refitted galley. The upper deck offers an additional dining space, pantry and bar, ideal for entertaining. Outdoor areas include expansive sunbathing zones on the sundeck and upper deck. Separate crew accommodation for 7 ensures efficient service while maintaining complete guest privacy.

LADY IN BLUE is a 41m displacement yacht by Rossinavi, built with a durable steel hull and extensively refitted in 2024. Her engines were overhauled to zero hours, new generators installed, and key systems upgraded, effectively renewing her technical lifecycle. This ensures reliability, efficiency and long-range capability, enhanced by newly fitted stabilisers for comfort underway and at anchor. Her contemporary interior by Dada & Associates complements generous exterior spaces. Accommodating 10 guests with 7 crew, she is a turnkey yacht equally suited for private use or charter, offering immediate readiness without the delays of new construction.

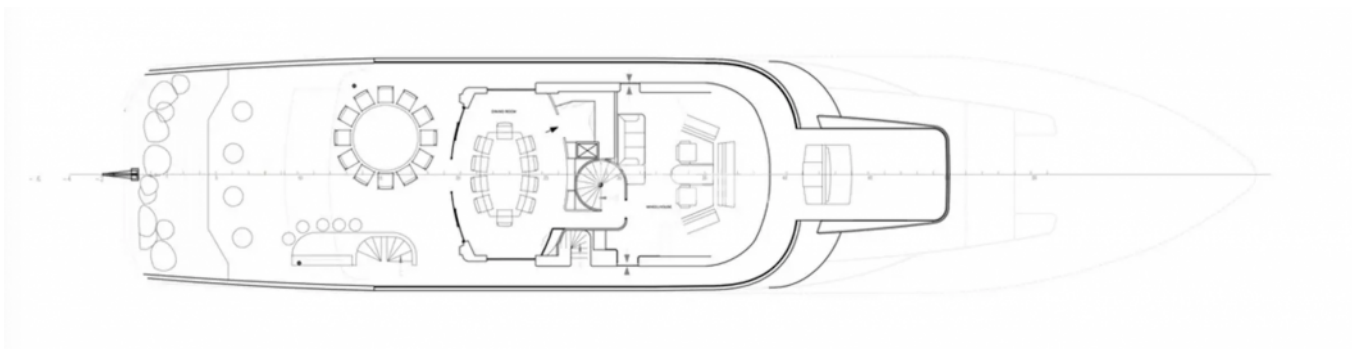
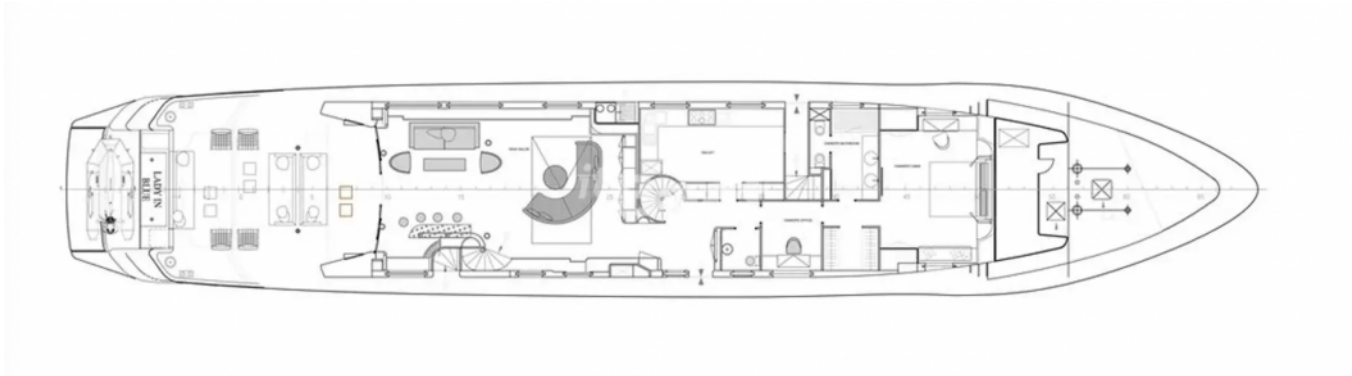
